A MESSAGE FROM THE MAYOR AND CITY ADMINISTRATOR

A Tale of Two Clintons

The following is considered a derivative work and was inspired by Charles Dickens' A Tale of Two Cities:

It was the age of revitalization, it was the age of remembrance. Paying homage to the iconic first sentence of Charles Dickens' A Tale of Two Cities. It was the epoch of steel and fiber, it was the epoch of murals and memory. It was the season of capital, it was the season of community. It was the spring of infrastructure, it was the winter of delay. Clinton, Iowa, stood at the crossroads of its past and its promise.

In the southwestern quarter of the city, where the Mississippi whispers to the rail lines, rose a titan of industry, Atlas Roofing, a colossus of capital, laid its foundation and steel began to rise vertically, promising 117 new livelihoods. Nestlé Purina, not to be outdone, summoned forth an Automated Supply and Retrieval System, a marvel of modern logistics. Other existing business continue to add new chapters to their owner industrial renaissance, the like of LYB, ADM, Custom Pak, Big River Packaging and many others continue to expand, provide high quality jobs and bring a sense momentum.

The roads, once weary and worn, began to stir. 36th Avenue South, born of state and private partnership, stretched its limbs toward the future. Water lines, like veins of progress, extended from Lincoln Meadows to the Rail Park, where Super 8 Logistics claimed 34 acres for transload transformation. Rail tracks are now unfurling to move freight in and out, breathing life into the Rail Park.

Yet not all was swift. Manufacturing Drive, a vital artery, found itself ensnared in federal red tape, its rebirth postponed until spring 2025. Still, the city pressed on. Today, Clinton is full of detour signs or as some residents call them, "progress signs"

as the road and one of the two bridges undergo full replacement. This vital corridor will soon include multi-modal capabilities for biking, walking, jogging, and running.

In the heart of Clinton, the old gave way to the new. Blighted buildings fell, clearing the way for new modern construction from the Developer "Build to Suit" Townhouses rising with purpose and promise. A new bus stop and driver break station at 6th Ave S. and S. 2nd Street stood as a testament to community needs. From a once-unused park space, a supportive housing development now takes root, designed to offer stability, dignity, and opportunity to those in need while growing alongside the remaining trees and soon-to-be-added amenities. Just a stone through from the downtown, the library, once split between two locations, continues to flourish with unity through reorganization, with the Lyons Branch lovingly maintained by the Friends of the Library.

It was the season of jubilation upon the banks of the mighty Mississippi, and the spirit of merriment did reign supreme. The skate park, alive with youthful vigor, rang with the clamor of wheels upon the double rip track, a modern marvel of motion and mirth. Music, that most democratic of arts, poured forth from every corner, from Tailgate & Tallboys, Clinton Symphony Orchestra, Finally Fridays, Music on the Avenue, Market Music at Four Square Park all conspired to fill the air with melody and memory, as if the very streets themselves had learned to sing.

The campground welcomed travelers and townsfolk alike, their RVs nestled beneath the summer sky, laughter rising with the smoke of evening fires and the scent of grilled fare. Down by the water's edge, the marina bustled with life with boats bobbing gently in their slips, kayaks and canoes soon to glide through the sloughs, and the Candlelight casting its warm glow upon the

river, a beacon of dining and delight.

And lo! The Showboat, that grand ship drydocked as a theatre of dreams, opened its season with a flourish, the Addams Family taking the stage with ghoulish charm and gothic glee, followed by wonderment of shows; Joseph and the Amazing Technicolor Dreamcoat, Bright Star and Almost Heaven (songs of John Denver). Applause echoed across the water, mingling with the hum of engines and the clink of glasses, as the city's heart beat strong with culture and camaraderie.

Not far from the river's bend, Riverview Stadium stood proud, its lights gleaming like stars summoned to earth. There, the LumberKings took to the diamond, swinging their wooden bats in the noble tradition of the Prospect League. The crack of the bat, the cheer of the crowd, the scent of popcorn and peanuts, it was baseball in its purest form, a summer ritual as timeless as the river itself with the LumberKings taking first place in the first half of the season.

It was, indeed, a time of renaissance and a summer of sound and spectacle, of community and celebration. Every corner of the city, from park to pier, from concert to curtain call, played its part in the great symphony of civic joy.

The parks, those green lungs of the city, did flourish. The swimming pool opened its gates to the sun-drenched multitudes, Eagle Point Park hosted travels from far and near, witnessed new marriages and celebrations on the Parks cliffs edges of the might Mississippi River and meanwhile back on the Riverfront echoed with the golden mist of sand on the volleyball courts, and the curious sport of pickleball, whose name belies its vigor,

was played with great enthusiasm by those who fancied themselves picklers of a sort.

Meanwhile, the invisible threads of progress, fiber optics, spread like wildfire across the land, and the city's voice, once faint and scattered, now rang clear through the quarterly Lighthouse, a newly burnished website, and the updated reporting system for citizens alike, which gave voice to the voiceless and ears to the indifferent.

The Parks & Recreation Department, too, underwent a renaissance most profound. A grand Objective Plan for the year 2025 was drawn, a compass for innovation and inclusion. The department, ever evolving, moved from Keri Door to Kisi, unlocking new realms of access. The Riverfront Study was completed, and PRAB was charged with extracting the gems of recreation from its depths. New Safety Town houses rose in anticipation of a golden jubilee, standing as sentinels of safety and imagination for the past

50 years.

New entertainments like Movie Nights, Parks Nights, a 7v7 Football League, and tournaments of volleyball and basketball all breathed new life into the community, as if the very soul of the city had been stirred from slumber. Two shade structures were installed at the Riverfront Pickleball Courts, partially funded by the Lions Club. A grant application is pending for an Eagle Point Park path, and several projects are underway: Lubbers Fountain scope development, Lodge floor funding, sauna installation at The Rec, and resurfacing of the Emma Young tennis court. As one resident put it, *"It's not just about what we're building, it's about what we're becoming."*

The tale was not merely one of steel and stone. It was a tale of homes, over 300 new apartments rising like phoenixes: Valley Bluff, Cottage Bluff, and more. New house developers danced through Riverstone Crossing, Zara Heights, Jordan Creek, and Mill Creek. Numerous other new homes and new townhouses brought life to forgotten lots, a testament to the

power of infill housing.

And in the shadows of progress, the city remembered. The historic 1905 YMCA building, now separated from its 1960s addition, prepares to be reborn as housing. The 1904 Lafayette Building stands ready to welcome over 60 new apartments. *"We're not just investing in infrastructure,"* said one city staff member, *"we're investing in identity."*

The City Administrator, the chronicler of this new age, spoke of fiscal prudence, sustainable growth, and the sacred bond between government and governed. He and his staff listened, responded, and didn't just encourage things to be built, not just structures, but trust.

Thus, Clinton stood, two cities in one. One of memory, one of momentum. One looking back with reverence, the other forward with resolve. And in the space between, a community found its voice, its vision, and its victory. Best said by one of Clinton's residents, *"Clinton's not just changing, it's coming alive."*

CITY OF CLINTON SIDEWALK REPAIR PROGRAM

The sidewalks of the city show a long history of neglect- cracked concrete, uneven pavement, and raised slabs that forced pedestrians into the street or grass. Recognizing the growing safety concern and public demand, the City Council decided to act upon it. A new sidewalk repair program was proposed aiming to prioritize repairs of damaged sidewalks. Backed by a dedicated funding plan, the initiative would restore the walkability and safety in neighborhoods for everyone.

The Voluntary Sidewalk Repair Program addresses the sidewalk maintenance needs and provides financial assistance to property owners to replace deficient sidewalks. This voluntary program allows all property

owners to participate in a cost-share program where the City would cover 50% of the cost of repairs and 75% for eligible low-income, single-family homeowners. The city sidewalks are to be inspected by the City Engineering Department with specific inspection criteria. An inspection report will then be mailed to the property owner with an application. Property owners who do not elect to participate in the program are liable for any injuries that could occur due to sidewalk defects left in disrepair. 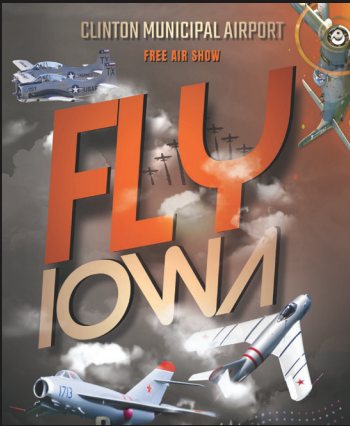

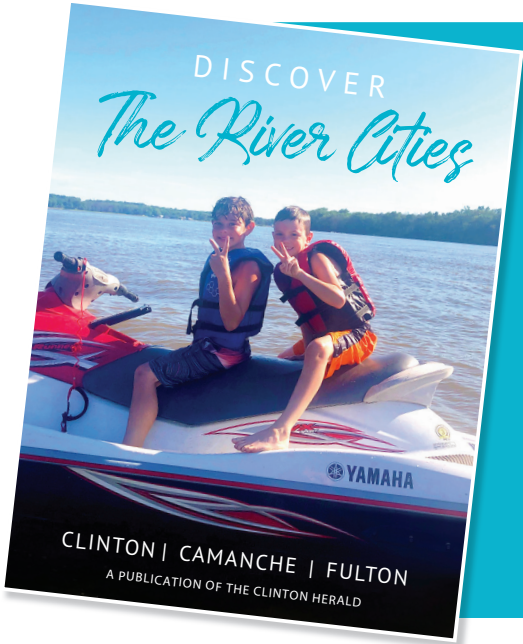

HANDS FREE DRIVING LAW

A significant change is coming to Iowa's roadways this summer as Senate File 22, the state's new hands-free driving law, officially goes into effect July 1, 2025. The legislation aims to reduce distracted driving by banning most manual cell phone use while operating a motor vehicle.

According to the Iowa DOT, over 1,000 crashes in 2023 were linked to distracted driving, statistic lawmakers hope to curb with this stricter legislation.

Under the new law, drivers are prohibited from

holding or manually operating a phone while the vehicle is in motion. This includes actions such as dialing numbers, texting, browsing apps, or taking videos. Instead, motorists are encouraged to use voice-activated or hands-free technology, such as Bluetooth or dashboard-integrated systems.

Key points of the law include:

- Use of handheld devices while driving is prohibited.
- Exceptions are made for emergency services, calling 911, and certain two-way or dispatch

- communications.
 - First-time violations may result in warnings as drivers adjust, but citations and fines are expected to follow starting in January 2026.
 - The law applies to drivers of all ages, expanding upon Iowa's previous texting-and-driving ban that only fully applied to young drivers.

 - Purchase a hands-free mount for your phone
 - Familiarize yourself with voice command features
 - Plan your route before driving
 - Keep your focus on the road, not the screen

Preventing Overdose: The Hidden Danger in Counterfeit Pills Containing Fentanyl

In recent years, a troubling and deadly trend has emerged across communities in the United States and beyond: a sharp rise in fatal drug overdoses driven by fentanyl-laced counterfeit pills. These pills are often nearly indistinguishable from legitimate prescription medications, making the threat especially difficult to detect. Understanding this crisis—and how to prevent overdoses—can save lives.

What is Fentanyl?

Fentanyl is a synthetic opioid used in medical settings to treat severe pain. However, illegally manufactured fentanyl has flooded the illicit drug market. It is extremely potent—50 to 100 times stronger than morphine—and just a tiny amount can be lethal.

Illicit fentanyl is often pressed into pills that look like prescription medications such as oxycodone, Percocet, Xanax, or even Adderall. These counterfeit pills may be sold online, on social media, or by dealers, and users often have no idea they contain fentanyl until it's too late.

The Overdose Risk is Real—and Rising

A dose of just 2 milligrams of fentanyl (about the size of a few grains of salt) can be fatal, especially for individuals without a tolerance to opioids. Many overdose victims believed they were taking a familiar prescription drug, only to unwittingly ingest a deadly amount of fentanyl.

Recognizing the Signs of Overdose

Prompt recognition of an overdose is crucial. Common signs include:

- Extremely slow or stopped breathing

- Blue or grayish lips and fingertips
 - Loss of consciousness or unresponsiveness
 - Gurgling or choking noises
 - Cold, clammy skin
- If you suspect someone is experiencing an overdose, call 911 immediately. Seconds matter.

How to Prevent Overdose

1. Never Take Unknown or Unprescribed Pills

Avoid taking pills that weren't prescribed specifically for you. If you didn't get it from a pharmacy, it's not safe—no matter what the person selling or sharing it says.

2. Carry and Know How to Use Naloxone (Narcan)

Naloxone is a life-saving medication that can reverse an opioid overdose. It's available without a prescription in many states and should be part of any emergency preparedness kit, especially for those at risk.

3. Spread the Word

Educate friends, family, and your community about the dangers of counterfeit pills and how to prevent overdoses. The more people know, the more lives can be saved.

IOWA LOWERS FIREARM CARRY AGE

What the 2025 Law Change Really Means

Beginning July 1, 2025, a new chapter in Iowa's firearm legislation will take effect—one that significantly lowers the age requirement to carry weapons. While the change appears to expand Second Amendment rights for young adults, it comes with crucial caveats. Understanding the new landscape—especially how it intersects with federal law—is essential for anyone who owns, sells, or carries firearms in Iowa.

The Big Shift: Minimum Age Now 18

Under the new law, individuals 18 years and older will be eligible to carry a firearm in Iowa. This marks a shift from prior state regulations that placed stricter age limitations on handgun possession and carry privileges.

This change opens the door for more young adults—particularly those aged 18 to 20—to lawfully carry firearms under Iowa law. However, when it comes to purchasing firearms, especially handguns, the rules get more complicated due to federal restrictions that remain in place.

Federal Law Still Reigns at the Gun Counter

Despite Iowa's changes, federal law prohibits federally licensed firearms dealers (FFLs) from selling pistols or revolvers to anyone under 21. This restriction is rooted in 18 U.S.C. § 922(t) and is not affected by state-level modifications.

To purchase a handgun from an FFL, a person must:

- Be 21 years of age or older, and
- Have either a valid permit to acquire or permit to carry, or
- Pass a federal background check.

No permits to acquire or carry will be issued to individuals under 21, which means that even if an 18-year-old can lawfully carry a pistol in Iowa, they cannot legally buy it from a licensed dealer.

Private sales, on the other hand, may still occur under Iowa law for 18- to 20-year-olds—but these transactions must still comply with all applicable federal guidelines.

Youth Access and Legal Boundaries

Iowa Code Section 724.22 outlines key changes regarding youth access to firearms and the responsibilities of adults who supervise or transfer weapons to minors.

- It is illegal to sell, loan, or give a pistol or revolver—or matching ammunition—to anyone under the age of 18.
- A first offense is classified as a serious misdemeanor.
- Subsequent offenses rise to a Class D felony.

That said, there are exceptions:

- Ages 18–20 may legally possess handguns if they are:
- On active military duty
- Working as a peace officer, security guard, or corrections officer
- Receiving firearms instruction from an instructor 21 or older

One previous provision allowing such possession under instruction has now been removed, suggesting a narrowing of the law's scope. For those under 18, handgun possession is only allowed with direct supervision by:

- A parent, guardian, or spouse who is 18 or older, or
- A certified instructor who is at least 18

“Direct supervision” is explicitly defined in law as maintaining physical presence, visual/verbal contact, and sobriety at all times.

Liability for Minors Under 14

A particularly important section of the law addresses liability for very young minors:

If a parent, guardian, or spouse (age 18+) allows a child under 14 to possess a handgun or ammunition—even under supervision—they are strictly liable for any damage or injury caused by the child's possession of the weapon.

This clause underscores the seriousness with which the law treats gun access for younger minors and the burden of responsibility placed on adults.

The Bottom Line

Iowa's new firearm laws aim to expand carry rights to more young adults—but the changes come with important limitations and legal nuances.

- If you're under 21, you may carry, but you cannot buy a handgun from a licensed dealer.
- If you're a parent or guardian, you bear legal responsibility for firearm access and misuse by minors under your supervision.

Understanding these distinctions is essential for staying compliant and safe. Whether you're a gun owner, firearms dealer, or parent, take time to review the updated code—and stay informed as interpretations and enforcement practices evolve.

CODE ENFORCEMENT

Chapter 94 Grass, Weeds, Vines And Brush

The City of Clinton is committed to maintaining a clean, healthy, and attractive community. As part of this effort, we'd like to remind residents and property owners of their responsibilities under Chapter 94 of the City Code.

What the Ordinance Requires:

- All residential, commercial, and industrial property owners must cut or destroy grass, weeds, vines, and brush when growth exceeds 8 inches in height.
- This includes all areas abutting road right-of-way, such as:
 - Boulevards
 - Side yards
 - Back alleys

Why It Matters:

- Health & Safety: Overgrown vegetation can harbor pests like rodents, ticks, and mosquitoes.
 - Community Pride: Well-maintained lawns enhance neighborhood appearance and property values.
 - Compliance: Failure to maintain your property may result in city action and associated costs.
- Don't Forget:**
Even the back of your property along alleyways must be maintained!

Grass Clipping In The Street
97.003 Placing Debris In / On Streets

As summer mowing season is in full swing, the City of Clinton reminds all residents and property owners of the importance of keeping our streets clean and storm drains clear.

What You Need to Know:

Under Chapter 97.003 of the City Code, it is unlawful to throw or deposit grass clippings, leaves, or any debris onto any street or alley.

This includes:

- Grass clippings blown into the street while mowing
- Leaves, trash, or other yard waste
- Any material that could clog storm sewers or pose a hazard

Why It Matters:

- Storm Drain Safety: Grass and debris can clog storm sewers, leading to flooding.
 - Environmental Protection: Debris in the street can wash into waterways, harming local ecosystems.
 - Public Safety: Loose debris can be hazardous to pedestrians, cyclists, and vehicles.
- What You Should Do:**
- Always blow clippings back into your yard or collect them after mowing.
 - Never sweep or blow yard waste into the street.
 - Help your neighbors stay informed and

compliant.

Chapter 98 Trees

As part of our ongoing commitment to public safety and neighborhood beautification, the City of Clinton reminds all property owners of their responsibilities under Chapter 98 of the City Code regarding tree maintenance.

What You Need to Know:

- Maintain Clearance: Property owners must ensure that any trees growing on or overhanging public streets and sidewalks adjacent to their property are properly trimmed.
- Minimum Clearance:
 - 13 feet above streets
 - 9 feet above sidewalks
- Why It Matters: Proper tree trimming ensures safe passage for vehicles and pedestrians, prevents damage to city infrastructure, and enhances the overall appearance of our community.

Enforcement Process:

If a tree is found to be in violation:

1. The city will issue a notice requiring the trimming to be completed within five (5) days.
2. If not addressed, the city may perform the trimming.
3. The cost of the work will be assessed to the property and collected in the same manner as property taxes.

Chapter 79.07 Parking Prohibited

The City of Clinton reminds all residents and property owners of the regulations regarding off-street parking in front yards, as outlined in the city's zoning code.

What's Allowed:

- Parking in the front yard is prohibited unless the vehicle is parked on an approved hard-surfaced driveway.
 - The front yard is defined as the area extending across the full width of the lot, from the front of the building to the front property line.
- Why This Matters:**
- Preserves neighborhood aesthetics
 - Prevents damage to lawns and public infrastructure
 - Supports property values and community pride
- Stay Compliant:**
- Use only paved driveways for parking in front of your home.
 - Avoid parking on grass, dirt, or any unapproved surface in the front yard.

Swimming Pools
Supplemental Regulations 159.045

As summer heats up, the City of Clinton

reminds residents of important regulations regarding the installation and maintenance of swimming pools, hot tubs, and spas.

Location Requirements:

- Front yards: Pools are not allowed in front yards.
- Side & rear yards: Pools (including decks) must be at least 2 feet from any side or rear property line.
- Corner lots: If the pool is:
 - 10 feet or less from the main building, it may align with the building line.
 - More than 10 feet from the main building, it must be at least 10 feet from the corner street side property line.
- A 10-foot visual clearance zone is required where a corner lot abuts an alley.

What Qualifies as a Pool?

Any structure over 24 inches deep intended for swimming, wading, or bathing, including:

- In-ground and above-ground pools
 - On-ground pools
 - Hot tubs and spas
 - Fixed-in-place wading pools
- Yes, this includes temporary pools!

Maintenance & Safety:

Under Chapter 90.02(N):

- Pools, spas, and hot tubs must be kept clean, sanitary, and in good repair.
- Security fencing is required per AG105.2 of the 2006 International Residential Code.
- Unclean or unsafe pools are considered nuisances and may be subject to penalties and abatement.

Signs In The Right Of Way 159.048
This Includes All Signage

The City of Clinton reminds residents, businesses, and event organizers of the regulations regarding signs and banners in public spaces, especially within the public right-of-way.

What's Not Allowed Without a Permit:

- No signs or banners may be placed in or overhanging the traveled portion of any public street or alley.
 - No signs may be affixed to city poles or property without written consent from the City Administrator.
- What's Allowed with a Permit:**
- Temporary signs or banners advertising public events of general importance may be allowed with approval.
 - The City Administrator must determine the event's significance and approve:
 - The dates the sign/banner will be displayed
 - The location and height
 - A visual exhibit of the proposed sign/banner
 - The City Engineer must confirm it can be safely suspended without obstructing views

or traffic.

- Liability Notice: Applicants are civilly liable for any damage to city poles or property caused by the installation of signs or banners.

Let's Work Together

These rules help maintain clear sightlines, safe roadways, and a visually appealing community.

Chapter 50.25 (3) City Garbage Totes

To maintain the cleanliness and safety of our neighborhoods, the City of Clinton enforces regulations on when and where garbage, yard waste, and recycling containers may be placed for collection.

What the Ordinance Says:

- Do not place containers on the parking, terrace, or alley more than 12 hours before your scheduled collection day.
- Remove containers from the parking, terrace, or alley within 12 hours after collection has occurred.

Why It Matters:

- Prevents clutter and obstruction in public spaces
- Reduces the risk of windblown litter
- Helps maintain neighborhood appearance and hygiene

Best Practices:

- Set out totes the evening before your collection day.
- Bring them back in promptly after pickup.
- Store containers in a location that does not obstruct sidewalks or alleys.

Chapter 90 Nuisance Ordinance Reminder

The City of Clinton is committed to maintaining a clean, safe, and livable environment for all residents. Chapter 90 of the City Code outlines what constitutes a nuisance and how such issues are addressed.

Common Nuisances Include:

- Accumulation of Rubbish or Garbage: All properties must be kept free of trash, debris, and unsanitary waste—both inside and outside structures
- Abandoned or Inoperable Vehicles: Vehicles that are unregistered, in disrepair, or left unattended for over 24 hours may be considered abandoned. Major repairs must be done indoors or in approved areas.

Why This Matters:

- Prevents health hazards like pests and disease
- Protects property values
- Enhances neighborhood appearance and safety

CLINTON REGIONAL WATER RECLAMATION FACILITY

The Regional Water Reclamation Facility (RWRF) continues to make major progress on its facility expansion, with several new systems going online this summer to improve how we treat and manage wastewater for the City of Clinton.

In July, we're excited to begin operating our brand-new **sludge dryer**. This system will significantly reduce the volume of biosolids we produce, which means fewer truckloads to haul and lower disposal costs. The dryer also creates a cleaner, more manageable product for land application, which supports our long-term sustainability goals.

Also now online are additional **aeration basins and final clarifiers**. These components are essential to how we treat wastewater, and the new equipment gives us more capacity and reliability. This is especially important as the community continues to grow and send more flow to the

plant. The extra treatment capacity helps us stay ahead of demand and maintain high-quality water standards.

Looking ahead to **August**, we'll be starting up our **anaerobic digesters**, also known as **reactors**. These digesters break down solids and capture **methane gas**, which we will clean and convert into **renewable natural gas (RNG)**. Once fully operational, this system will allow us to turn waste into energy, reducing our environmental footprint.

Each of these systems is a major step toward modernizing the RWRF and preparing Clinton for the future. We appreciate your continued support as we bring these critical upgrades online.

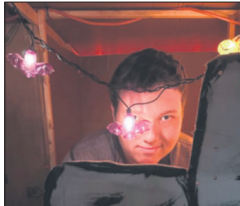



PUBLIC WORKS

Public Works is responsible for a wide range of city services that touch the lives of residents on a daily basis—from maintaining roads, city buildings, and sewer systems to collecting solid waste and keeping the city’s fleet in working condition. Public Works delivers essential services to the residents of Clinton.

Streets:

The Streets Division is tasked with maintaining the City’s roads, right of ways, alleys, and street signage.

What is a Right-of-Way?

A right-of-way is public land designated for transportation and utility purposes. It includes streets, side-walks, curbs, medians, and sometimes areas between the street and private property.

Key Responsibilities:

- Pothole patching and alley grading.
- Snow and ice removal for safe winter travel.
- Street sweeping and storm inlet cleaning.
- Signage installation and traffic markings.

These efforts help reduce vehicle damage, improve pedestrian safety, and maintain critical infrastructure throughout all seasons.

Facilities and Grounds:

This division oversees the upkeep of all city-owned buildings and public grounds. From City Hall to parks, trails, and sports complexes, their work ensures public spaces are functional, safe, and welcoming.

Key Responsibilities:

- Routine maintenance and repairs of city buildings and grounds.
- Seasonal care of parks and trail systems, including mowing, trimming, and snow removal.
- Landscape management and beautification projects in public spaces.

By preserving public assets, this team ensures tax dollars are protected and community spaces remain inviting for residents and visitors alike.

Solid Waste Division:

The Solid Waste Division provides essential curbside services to Clinton households, including garbage collection, recycling, and yard waste removal.

Solid Waste (Garbage):

Collected weekly, residential garbage is transported to the Clinton landfill.

Recycling:

Accepted recyclables are collected every other week. This includes paper, cardboard, certain plastics, and metals. Recycling reduces landfill use, saves natural resources, and promotes environmental sustainability.

Yard Waste:

During the growing season, yard waste—such as grass clippings, leaves, and branches—is collected and taken to the Clinton Landfill. Landscaping items such as dirt, sod, mulch and rock are not accepted.

Sewer Maintenance:

The Sewer Maintenance Division is responsible for the inspection, cleaning, and repair of the city’s sanitary and storm sewer systems. This includes hundreds of miles of underground pipe that transport wastewater to treatment facilities or direct stormwater runoff safely out of the city.

Sanitary Sewer Overflows (SSOs):

A SSO occurs when untreated sewage escapes from the sewer system—typically due to blockages, heavy rain infiltration, or equipment failure. The city works diligently to prevent overflows by:

- Jetting and inspecting sewer mains.
- Removing tree roots, grease, and debris.
- Rehabilitating aging infrastructure.
- Responding rapidly to any backup or overflow event.

Routine maintenance prevents costly emergencies and ensures compliance with federal and state environmental regulations.

Fleet Maintenance:

The Fleet Maintenance Division keeps over 100 pieces of equipment and vehicles running across all city departments. This includes dump trucks, garbage trucks, snowplows, fire trucks, street sweepers, mowers, sewer jettlers, and more.

Key Responsibilities:

- Preventative maintenance like oil changes, tire rotation, and fluid checks.
- Emergency repairs to avoid service disruption.
- Safety inspections to meet DOT and OSHA standards.
- Equipment lifecycle tracking to plan replacements cost-effectively.

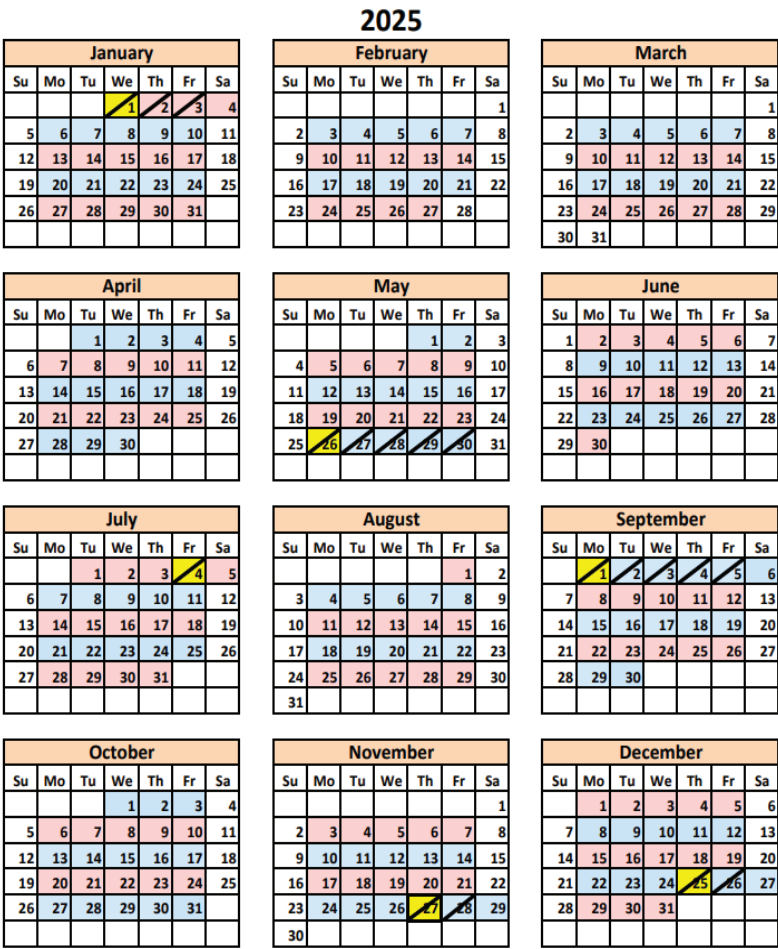

Advance Scheduling of Inspections Helps Ensure Quality and Safety

The Building Safety Division is reminding contractors, developers, and property owners about the importance of scheduling building inspections in advance. Same-day inspection requests can limit preparation time for inspectors and potentially affect the quality of inspections. Effective scheduling allows inspectors to thoroughly review project details and focus on ensuring each inspection is conducted with the attention required to ensure the health, safety, general welfare, and sustainability of the community.

Inspections are most effective when sufficient preparation time is allowed. Last-minute or same-day requests can lead to incomplete inspections or delays, as inspectors may not have adequate opportunity to review approved plans, site-specific conditions, and applicable code requirements. Advance scheduling supports a thorough inspection process that prioritizes safety and compliance for the community.

It is encouraged to schedule inspections at least 24 hours ahead of time. This approach reduces the likelihood of encountering potential issues, and contributes to a smoother, more efficient permitting process. Ultimately, careful planning benefits everyone involved by helping to maintain high standards for construction quality and public safety.

The Importance of a Thorough Plan Review

A comprehensive plan review is one of the most important steps in the building permit and inspection process. A well-executed plan review not only verifies code compliance but also identifies potential construction issues early in the process — before materials are ordered and work begins. By catching problems at this stage, the Building

Safety Division helps reduce costly delays, contributing to a smoother and more efficient project for both contractors and property owners.

Plan review serves as a critical quality control checkpoint. It ensures that building components meet the applicable codes and standards. Plan reviewers must approach their work with attention to detail, technical knowledge, and an understanding of construction practices. This thorough review process ultimately supports the goal of protecting public health, safety, general welfare, and sustainability in the built environment.

Investing time and care in the plan review phase also benefits builders by improving communication and setting clear expectations before work begins. It fosters collaboration between the Building Safety Division and the construction team, helping to minimize misunderstandings and inspection issues later in the project. A strong plan review leads to safer buildings, greater public trust in the permitting process, and a higher standard of construction within the community.

Regular inspections protect not only the future occupants of a structure but also the financial investment of property owners and the professional reputation of contractors.

Requesting inspections at the proper stages of construction is essential for keeping a project on track and in compliance.
