Separate Sewers – A Better Way Of Life

Over the last year, crews have been working to completely transform the condition of 25th Ave North from Grant Street to 3rd Street. 25th Avenue North was once a failed pothole ridden roadway, lacking curb and gutters, proper drainage and sporting a combine sewer susceptible to basement backups, localized flooding and heaps of frustration due to regulatory issues. Virtually every time it rained, the city was discharging raw sewage directly into the Mississippi River, due to the undersized combined sewers and pumping stations. As part of the City of Clinton’s long term control plan for combined sewer compliance with the Iowa DNR & US EPA, we had to do something. Two things were sure, it wasn’t going to be cheap and it sure wasn’t going to be quick.

Beginning in 2013, the City of Clinton built two large pumping stations next to the levee near the 25th Avenue Boat Ramp. The first lift station is a prominent 25 foot tall structure which is necessary to pump the eventually separated storm water runoff through the levee. The old storm water station built by the Corps of Engineers was only sized to handle combined sewer overflows with a certain amount of street ponding allowed behind the levee. If we were to separate the entire north end of

Clinton, we needed something much more massive. After working for years through corps of engineers permitting, we finally were allowed to bore a 72” sewer through the levee, which was sized for eventual sewer separation of the entire north end of town.

The second lift station is an underground chamber with working constantly to pump the sanitary sewage from home and businesses in the north end of town. We also oversized the lift station by a factor of 10 to account for the private inflow from residential sump pumps and infiltration into the old clay sewer lines in the basin. The sewage is pumped through a force main all the way down to Riverview Park, where it dumps into 1st Avenue Pumping station, where the sewage can be pumped to the treatment plant. With the increased capacity, the goal is to limit combined sewer overflows to the river during smaller rain events. While the pumping stations project had a hefty price tag of \$8 million, the project was necessary not only for compliance with DNR standards, but to allow the necessary head room to construct sewer separation projects in the north end of Clinton which will eliminate the many basement backups that routinely occur in the area.

While the majority of the money was already spent, through 2015 the City of Clinton had not yet harvested the fruits of our labor. The task before us was separation of the nearly 100 acre area of the north end area between Main Avenue and Turtle Creek. We started small with a DNR funded project along Main Avenue, which involved storm sewer, permeable parking bays and alleys for additional storm water treatment, along with other streetscape and bio features. One of the unique aspects of this project is that the businesses of the Lyons district received a much needed facelift to their street frontage. The DNR sponsored the project with \$800,000 in funding to pay for the parking bays, green alleys, and storm sewer piping.

Our plan for the rest of the 25th Avenue North area was complete reconstruction of all streets and sewers. This project would replace the existing 100 year old clay and brick sewer with a new deep PVC sanitary pipe, which would drain to the underground sanitary lift station constructed in 2013. All residential services were tied into the new line, and the city street drains were disconnected from this system, which will alleviate the basement backups that have continually

CLINTON, IA — Bring your bike helmet! That’s what the Clinton, Iowa Convention and Visitors Bureau is telling people to do so they can take advantage of their new MyBike rental program.

By downloading the free, self-serve KoloniShare app on their mobile devices, visitors and community members interested in riding along the Mississippi River and in downtown Clinton can rent bikes at six docking stations: Eagle Point Park, Lyons Neighborhood, Lyons Tech Park, Joyce Island, the Visitors Information Kiosk at Riverfront and Downtown. Bike rental is \$1 for the first hour, every hour after will be prorated.

“We wanted to provide a user-friendly way for people to rent bikes, be active and take part in the great

experiences Clinton has to offer,” said Mary Seely, Director of the Clinton Convention and Visitors Bureau. “Now, families can quickly and easily ride on the Discovery Trail from downtown to Eagle Point Park, where they can enjoy the view of the widest pool of the Mississippi River.”

The white bikes display their logos and are protected by a variety of anti-vandalism features. 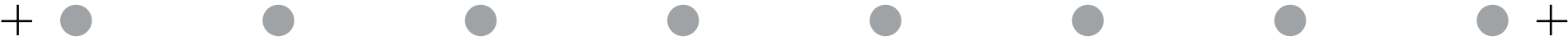

We are extremely excited to see winter finally give up its hold on our area, and allow the warmer weather to join us in Clinton Iowa! Although it made us laugh, we are glad that we don't have to refer to this month as Mayuary or December 121st. Along with warmer winds come currents of change and improvements to our great city.

Our Engineering Department has been busy!

- Improving the streets at 25 Ave North with curb, gutters and permeable pavers
- N 3rd Street Main up to 37th Ave North all resurfaced
- Repaving 13th Ave North west of Mill Creek
- Deer Creek Bridge replacement
- Turtle Creek sewer separation and bridge work
- Car Barn Ditch clean up

Did someone ask about the Parks & Recreation Department?!

The Jurgensen Soccer complex is undergoing a major overhaul! There will be topsoil placement and construction of utilities for the restroom and concessions project and the irrigation of the upper fields. All of this should occur over the next month, with paving of the parking lot scheduled for May or June. The Parks and Recreation Department appreciates everyone working together to have alternate soccer game/practice locations until the Jurgensen Soccer complex is open in the Spring of 2019.

The Let's Live Healthy Clinton initiative comes to mind as we see the Parks and Recreation working on numerous projects that will assist in the quality of life for folks in Clinton. These projects range from a Drop Slide at the Swimming Pool; new LED Softball Lights and turf improvements at the fields at Emma Young Park; the City/CVB's Bike Share Program; Pickle Ball Courts at the Erickson Center; and finally parking improvements at the Erickson Center.

**Speaking of stuff to do** - just around the corner in Downtown Clinton will be Music on the Avenue on Thursday evenings; Finally Fridays are kicking off June 8th; and right next door is the Lumberkings baseball team - already on a winning streak! Finally, as remodeling continues on the Showboat Theater, the opening show will be Jesus Christ Super Star on June 7th.

One thing that we always look forward to seeing because it assures us that summer is here - is the reappearance of boats at the marina; A full deck of folks dining at the Candle Light; and people exercising on Riverfront Drive, either walking, jogging, or biking; and finally the beautiful splendor as the Arboretum blooms into full vibrancy.

City staff and officials are committed to continuous improvement. We recently submitted Clinton as one of the cities to receive an Opportunity Zone designation by the United States Treasury. The Opportunity Zones program provides a tax incentive for investors to re-invest their unrealized capital gains into Opportunity Funds that are dedicated to investing in cities like Clinton. In addition, Clinton was provided a Community Development Block Grant (CDBG) for the rehab of homes that may be re-sold to a prospective owner-occupied resident. This will be in partnership with East Central Intergovernmental Association (ECIA). In addition, the city is working to continue the other CDBG Home Rehab program that offers over \$25,000 to assist in fixing a family-owned residence. We are also extremely excited to have the HUD Lead Abatement Program begin the removal of lead from homes. As folks prepare for home improvements in the spring, the city is also poised to demolish over 39 nuisance properties. As if all of this isn't excitement enough - we are thrilled to see the old Ashford Campus become a home again as the community welcomes the new international students that will join our community.

Some issues that we work on are not as glamorous as the items listed above ... but definitely a win for the city! The

recycling program has seen an increase of over 234 tons of single stream recycling in the first six months of the program along with a decrease of 178 ton of solid waste. This illustrates how a community can come together and truly make changes.

It is truly amazing the number of events and happenings that occur from May to September - through the hands of volunteers. Day in and day out the countless hours put in by these people makes us extremely proud. As we have written before ... life is too short ... take time to not only stop and smell the flowers

(especially by the River because folks will start working the flower beds soon) but to say hello to others, pick up the trash on the sidewalk, and work each day to make Clinton an awesome place to live, to work, and to play. Together we can accomplish anything!

Finally, remember it is all about thinking **positive** and remembering that **team work** can accomplish anything. This is **our** city and we are grateful to be able to represent the citizens of Clinton. The more transparent and open we all are with communication - the better the entire city will be.

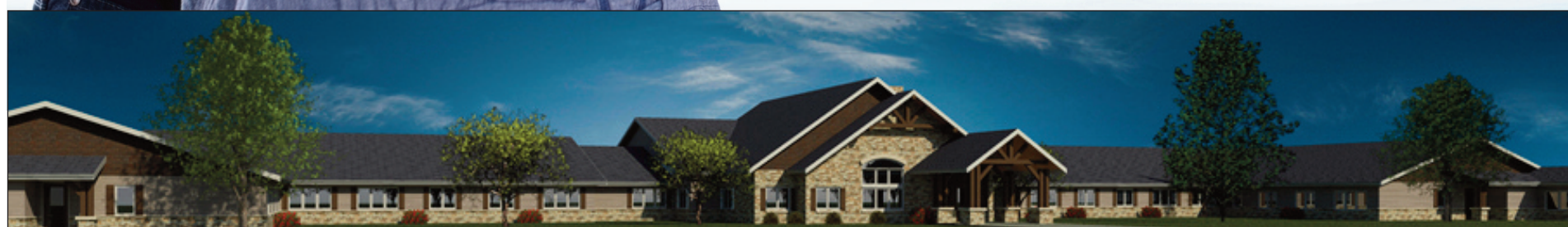

## Keeping Your Vehicle Safe

In the February Lighthouse newsletter, we published an article titled “Crimes of Opportunity” in which we encouraged the citizens of Clinton to lock their cars, bring in bikes from the yard, and to keep their houses secure.

In this issue, we again wish to revisit the crime of opportunity theory as it pertains to your vehicle. So far during calendar year 2018, Clinton police officers have responded to more than 25 reports of stolen vehicles. Police recovered nearly all the vehicles shortly after they were reported stolen, and fortunately, the vehicles had no damage. The recent uptick in stolen vehicles is not associated with one neighborhood, or location, but throughout the city. We cannot stress enough the best deterrent from vehicle theft is to **LOCK YOUR CAR AND TAKE YOUR KEYS**. A vehicle theft may start as simple as a person rummaging through your unlocked vehicle looking for loose change, or small items of value; however, when that person finds a set of keys left or “hidden” in the vehicle, the probability of your vehicle becoming a stolen vehicle increases dramatically.

The winter season is coming to a close. The practice of starting your vehicle to warm it up will be coming

to an end. Hot summer days are on the way which will cause us to leave our vehicles running to keep them cool during the summer heat. If you must leave your vehicle unattended while running, always lock it. The criminal element is becoming brazen in taking the chance to steal your vehicle. Recent television news stories from the Quad Cities may play a part in fueling the bravado these criminals have knowing their chances of being caught are low, and the theft may afford the criminal some bragging rights among his criminal peers.

Most of our recent vehicle thefts have been crimes of opportunity. You can take that opportunity away by making the potential criminal move on down the road to the next vehicle.

### Tips for Keeping Your Car Safe:

- Park in a well-lit area. Use your garage, if you have one.
- Remove all valuables from the vehicle, including loose change, iPods, jewelry, keys, electronics, purse/billfold, etc. You may think you have a good hiding place for your keys, but if you

thought of it, so did the thief. Do not leave car keys in the visor, in the center console, under the floor mat, or in a wheel well. Take the keys with you.

- Lock your car even if parked in your driveway, or in the street in front of your house. This is the best deterrent against a stolen vehicle.
- Do not let your vehicle run unattended while warming it up, or while making a quick stop at the store (refer to previous point).

### If Your Car is Stolen:

Report it to your local police agency immediately and be prepared to provide your vehicle license plate number, and the make, model, color, and any unique features that make the vehicle stand out.

If you recover your vehicle contact the agency you reported it stolen to.

For the most part, stolen vehicles are a crime of opportunity. You are the best defense against having your vehicle stolen. **LOCK YOUR CAR AND TAKE YOUR KEYS**.

## City of Clinton Noise Control Ordinance

Winter is finally loosening its grip and the days are becoming warmer. Soon we will be hearing the sounds of summer – lawn mowing, construction work, and birds chirping at 5:00 a.m. through open windows. We cannot do anything about the birds, but we can provide you with the specifics of the City’s noise ordinance.

No one shall use or operate a radio, television, boombox, stereo, MP3 player, speaker, CD player, or any device that produces sound in a manner which unreasonably disturbs the peace, quiet, and comfort of neighbors and passersby, or is plainly audible at a distance of 50’ from any person upon a public way. This does not apply to loudspeakers/public address systems, emergency signaling devices, car alarms, and ice cream trucks.

No one shall operate a vehicle which unreasonably disturbs the peace, quiet, and comfort of neighbors and passersby, or is plainly audible at a distance of 300’ from any person upon a public way.

No one shall sound any horn, or audible device of any motor vehicle while not in motion, nor shall it be sounded for any unnecessary or unreasonable period of time.

### There are a few exceptions:

- Lawn and garden equipment may be operated between 7:00 a.m. and 9:00 p.m.
- Chainsaws may be operated between 7:00 a.m. and 9:00 p.m.
- Construction noise (erection, demolition, excavation, drilling, sawing, hammering, etc.) is allowed between 7:00 a.m. and 9:00 p.m.
- The emission of sound in the performance of emergency work. For example, if a water main breaks, work will commence immediately, despite the time of day.
- Snow removal equipment may be operated between 6:00 a.m. and 12:00 midnight. City-owned or hired snow removal equipment may be used regardless of hours of operation.
- Emission sounds from ice cream trucks are allowed between 9:00 a.m. to 9:00 p.m.

**The violation of the noise ordinance is a misdemeanor punishable with a fine.**

## Clinton Curfew Ordinance

As spring quickly approaches and the weather warms, more and more people will spend time outdoors. Children are no different – they will want to be outdoors and stay outside later and later. It may become more difficult for a responsible adult to know the whereabouts of their child. Nevertheless, the City of Clinton has a curfew ordinance. The Clinton Police Department wants everyone to know the specifics of the curfew ordinance.

**Unless accompanied by a responsible adult, no child under 14 years-of-age shall be in any public place in the City of Clinton during the following times:**

Sunday through Thursday:  
10:00 p.m. through 6:00 a.m. each day

Friday and Saturday:  
11:00 p.m. through 6:00 a.m. each day

**Unless accompanied by a responsible adult, no child age 14 to 17 shall be in any public place in the City of Clinton on any day between 12:00 midnight through 6:00 a.m.**

**There are a few exceptions to these hours:**

1. A responsible adult accompanies the minor.
2. When the minor is on the sidewalk or property where the minor resides.
3. The minor is traveling between home and one of the following exceptions:
  - a. Minor's place of employment
  - b. Minor's place of religious activity
  - c. Governmental or political activity
  - d. Professional entertainment, with proof of attendance
  - e. School activity
  - f. Assembly such as a march, protest, demonstration, sit-in or meeting of an association for the advancement of economic, political, religious or cultural matters, or for any other activity protected by the First Amendment. (all of these activities must be within one hour after the end or before the beginning of the excepted event)

4. The minor is on an emergency life, property or medical errand for a responsible adult.

5. The minor's business, trade or occupation in which the minor is permitted by law to be engaged, requires the presence of the minor in a public place.

It is unlawful for any responsible adult knowingly to permit or to allow a minor to be in any public place in the city within the time periods outlined above.

**If Your Child is Charged with a Curfew Violation:**

The officer will take the minor into custody, or issue a citation. The officer will make an effort to notify the adult responsible for the minor. The officer will release the minor to the adult upon the promise of the person to produce the child in court when required.

A curfew violation is a simple misdemeanor punishable by up to a \$100.00 fine, or performing community service as ordered by the court.

National Bike Month  
Safety Reminder

The Clinton Police Department is asking the public to be cautious of bicyclists in the coming weeks and throughout the summer. The month of May brings more favorable weather for cyclists and designated as National Bike Month with several bike friendly activities planned. Wednesday, May 9th National Bike to School Day. We, as the public, need to be extra vigilant for younger cyclists in and around school areas during morning hours and afternoons when schools dismiss. The week of May 14 - 18 is National Bike to Work Week. Friday, May 18th is the Gateway Area Bike to Work Day and there will be an increase in cyclists on the roadways.

Motorists are encouraged to drive cautiously and reduce speeds when encountering cyclists. Bicyclists are considered vehicles and should be given the appropriate right of way. The Iowa Attorney General's Office issued an opinion, "When passing, you must give the cyclist the entire lane, waiting for legal, safe road and traffic conditions before you pass as you would when passing another motor vehicle." Be patient and allow extra time for cyclists to traverse intersections. Be considerate by looking for cyclists when opening car doors and recognize hazards cyclists may face. Children are often unpredictable on bicycles when turning and slowing down unexpectedly.

Cyclists must obey all the traffic laws that apply to motorists. Be predictable and always ride in the same direction as traffic, using hand signals when stopping and turning. Ride in a straight line without swerving between parked cars, and use the farthest right lane heading to your destination. Check for traffic before entering the street or intersection, anticipate hazards, and adjust your position in the roadway accordingly.

Cyclists should always wear a helmet and bright clothing to assist in being visible to motorists. Clinton city ordinance requires cyclists to have a white light to the front and red light, or reflector to the rear when operating a bicycle after dusk.

The Clinton Police Department will be providing focus on traffic enforcement to ensure the safety of both cyclists and motorists on Clinton streets.

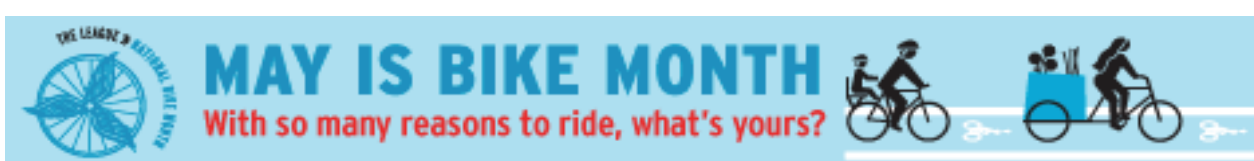

## 2018 National EMS Week

National EMS Week is fast approaching and is being recognized the week of May 20th-26th this year. The theme for this year is "Stronger Together". During this week the following topics are emphasized; Safety, Education, EMS for children, Save-A-Life Day and EMS recognition. This overall theme is particularly poignant in a year where the load on EMS is putting an even heavier burden on an already stressed profession. The past year has seen an increase in school shootings, mass public shootings and bombings. And now shows the need for innovative training in response to these threats. Bullet proof vests, helmets and rescue task forces have entered the vocabulary in the EMS world in an attempt to adapt to these ever increasing violent issues. Never has working with the public, our law enforcement partners and schools been more important to the outcome of a successful program.

The Clinton Fire Department responded to 4509 calls in 2017 of which 3600 were EMS related. There is a heavy emphasis on providing quality EMS

care to the public which is why all members of the Clinton Fire Department are trained to the paramedic level, as this allows us to address those needs. The Clinton Fire Department works hard to prepare for all types of emergencies and trains regularly to sharpen and enhance those skills. The CFD has been at the forefront of the Rescue Task Force or RTF (coordinated responses for active killer events) training for the state of Iowa and this part of the country. The CFD was one of the first departments with written policies / SOGs on this topic and have invested over 200 hours of training within the fire department and in conjunction with the CPD. The CFD is determined to lead the way with a progressive EMS program.

The fire department also is charged with educating children on what to do in case of an emergency. They learn the importance of 911 and what constitutes an emergency. The department offers tours of the ambulance for pre-k, elementary and scouts to discuss medical emergencies and equipment. High

schoolers and staff are becoming familiar with CPR and automatic external defibrillators.

The safety of our firefighters is of utmost importance, as the lines of a firefighter/paramedic are continually blurring. The addition of the vests and helmets to help protect our crews are an example of the constant need for increasing safety equipment in a changing world. We applaud our crews for the risks they take to bring quality emergency care to all members of the community and their willingness and dedication to helping others.

As stated above, "Stronger Together" is the motto of the 2018 National EMS Week so we pause to acknowledge the men and women of the Clinton Fire Department who are on the front lines when called to respond to those we are sworn to serve. Please take a minute to thank any of those who carry the title of "first responder", because without their dedication and service the CFD would not be as ready, trained and skilled as they are today.

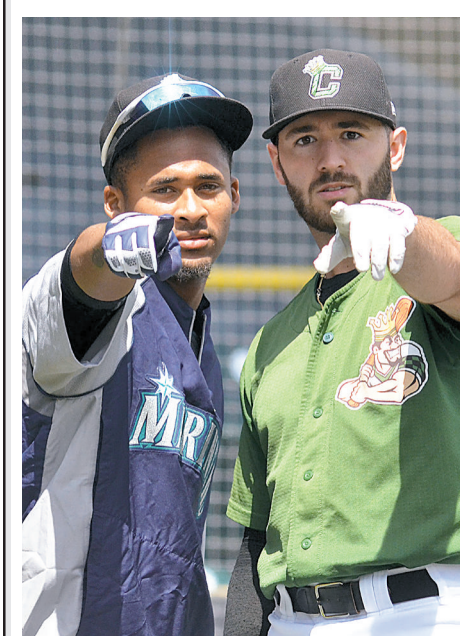
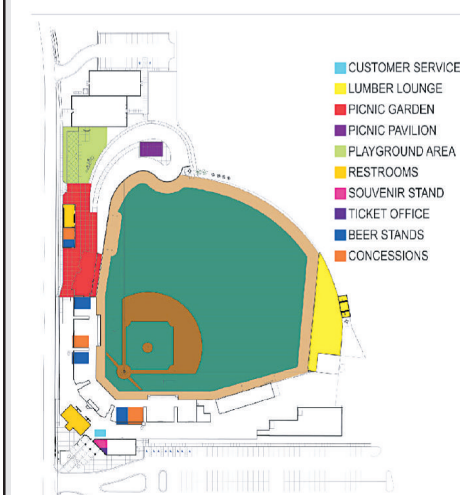

## CITY OF CLINTON PROPERTY OWNERS

**Chapter 94 of the Code of Ordinances of the City of Clinton,**

Requires owners of residential property to cut their grass, weeds, vines and brush when it exceeds eight inches in height. All owners of residential property shall maintain their property and the abutting boulevard by cutting or destroying all grasses, weeds, vines and brush when the growth exceeds eight inches in height.

Only one notice per calendar year will be sent on violations of Chapter 94 of the Code of Ordinances. Subsequent violations will not receive a written notice prior to city contractor mowing the property. If the property is not being maintained, the City will have a contractor do the required work and assess a \$200.00 fee, against the property.

Please be aware – it is against City Ordinance to blow cut grass into the roadway and gutter. Yard debris clogs up storm drains and can contribute to sewer backups. Also – if you have a storm drain / catch basin in front of your house, please keep it clear, to ensure all runoff drains properly.

## § 97.003 PLACING DEBRIS ON

It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.

# City Ordinance Regarding Tree Responsibility

## § 98.06 DUTY TO TRIM TREES

The owner or agent of the abutting property shall keep the trees in or overhanging the street trimmed so that all branches will be at least 13 feet above the surface of the street and nine feet above the sidewalks. If the abutting property owner fails to trim the trees, the city may serve notice on the abutting property owner requiring that such action be taken within five days. If such action is not taken within that time, the city may perform the required action and assess the costs against the abutting property for collection in the same manner as a property tax. Except as allowed in this section, it is unlawful for any person to trim or cut any tree in a street or public place without first obtaining authorization from the city. The Building and Neighborhood Services Official or his or her designee shall have the power to enforce this section.

(Iowa Code §§ 364.12(2)(c), 364.12(2)(d), 364.12(2)(e), 364.12(3)(b)) (Ord. 2437, passed 12-14-2010) Penalty, see § 98.99

(Iowa Code § 321.369) (1999 Code, § 135.03) Penalty, see § 10.99

**Please be aware** that tarps and/or covers are required by City Ordinance on any and all waste being transported to the Clinton County Solid Waste Agency (aka the Landfill).

## § 50.27 LOADING

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be covered to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned.

# Severe Weather Preparedness

- Listen to local area radio, NOAA radio or TV stations for the latest information and updates.
- Watch for tornado danger signs: dark, often greenish clouds — a phenomenon caused by hail; a wall cloud — an isolated lowering of the base of a thunderstorm; or a cloud of debris.
- Move or secure any of the items on your list of items to bring inside or anything else that can be picked up by the wind.
- Bring your companion animals indoors and maintain direct control of them.
- Go to a safe place in your home where household members and pets will gather: a basement, storm cellar or an interior room on the lowest floor with no windows.
- In a high-rise building, pick a hallway in the center of the building. You may not have enough time to go to the lowest floor.
- In a mobile home, choose a safe place in a nearby sturdy building. If your mobile home park has a designated shelter, make it your safe place. No mobile home, however it is configured,

is safe in a tornado. If you have access to a sturdy shelter or a vehicle, go there immediately, using your seat belt if driving.

- If you are driving, stay away from bridge/highway overpasses.
- If strong winds and flying debris occur while driving, pull over and park, keeping your seat belt on and engine running. Put your head down below the windows, covering your head with your hands and a blanket.
- After a tornado, let friends and family know you are safe.
- If evacuated from your home, return only when authorities say it is safe to do so.
- Listen to local news or a weather radio.
- Check for injuries. If you are trained, provide first aid to people in need until first responders arrive.
- And we would like to add: **Be ready.**
- Assemble an emergency kit now. Practice where you would shelter during a storm now. Talk with your family about how you would contact each other, or where to meet, in the event of a storm.

## BURN RULES:

From April 1st - May 15th, the City of Clinton will allow open burning for those residents with lots of one acre or larger on Tuesday, Thursday and Saturdays between the hours of: 10 am – 5 pm, weather and wind permitting. Fires must be no closer than 25 feet to a structure or other combustible materi-

al. Open burning is limited to: piles of clean, dry, untreated wood and lumber and landscape waste. The piles should not be burned larger than 3 feet in diameter and 2 feet high. All fires must be attended by an adult with an extinguishing agent readily available.

## ANIMAL CONTROL ISSUES:

The procedure for removal of small dead animals (i.e., dog, cat, squirrel) in a roadway is to contact the Clinton Police Department non-emergency number at: 563-243-1458 and the Public Safety Officer (PSO) will assist with removal.

For removal of live, medium sized animals (such as a raccoon), contact:

Eric Perry, the “Wildlife Wrangler” at: 563-559-6989. Eric will capture the animal for the homeowner and release it into the country for a fee. For large dead animals (such as deer) that are too large for the PSO to remove on their own, the Public Works Department may be called upon to assist with removal.

## Single Stream Recycling:

Dear City of Clinton Residents -

Thank you for continuing to make our Single Stream Recycling program a success!

Since the last Lighthouse article, we are happy to report that we have now increased our recycling to 39 tons per month. And, in turn, the amount of solid waste (garbage) has significantly decreased from 30 to 20 tons per month.

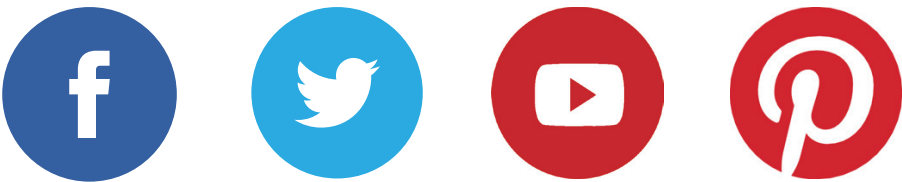

Solid Waste Department Policy on Yard Collection

The Solid Waste Department has set standard start and end date for yearly yard waste collection as the following:

Start of Yard Collection: 1st week of April

End of Yard Collection: Last week of November or with the first snowfall

\*As always, these dates are subject to the weather

The rationale for the dates are as follows: when the temperatures are below freezing, the moisture in and around the material in the yard carts will freeze everything together, which prevents it from coming out when we empty it. This in turn, may also cause the cart to split/crack or become damaged in some other way. The

other reason for not starting yard collection until April, is that at our current staffing levels, we are not able to adequately transition from our winter to our spring/summer duties until that time.

We have heard from many of you wondering why we stop our yard collection so early compared to several of the surrounding communities. The reason for this is because those communities do not use carts for their yard waste disposal. They use bags that are hand loaded onto the trucks. They do not run the risk of damaging carts because of the waste material freezing inside a container. It is the City's goal to alleviate any confusion.

Peddlers, Solicitors, And Transient Merchants

CITY CODE CHAPTER 112

What is a peddler, solicitor or transient merchant?

**PEDDLER.** Any person carrying goods, merchandise or services who sells or offers for sale such goods or merchandise from house to house or upon the public street including any person who takes orders house to house for goods, merchandise or services for later delivery.

**PEDDLING.** The selling or offering for sale goods, merchandise or services which are carried by a person from house to house or upon the public streets and including the taking of orders house to house for goods, merchandise or services for later delivery.

**SOLICITING.** Any person or organization, unless exempted by another provision of this chapter, who shall solicit contributions of funds personally or through an authorized employee, agent, or representative by the direct solicitation of money or by the sale of buttons, tokens, candies or other items of nominal value intending that all or a substantial portion of such funds be used for the procurement of necessities for one or more individuals or for medical, educational, religious or other purposes toward the benefit of the community.

**TRANSIENT MERCHANT.** A person principal or agent who engages in a merchandising business from a temporary location or structure in the city and who for the purpose of carrying on such business hires, leases or occupies any land, structure, trailer or truck for the exhibition and sale of such goods, wares, or merchandise and including the sale of any article, food, beverage, fruit, vegetable or farm product unless otherwise exempted by another provision of this chapter. Temporary association with a local merchant, dealer, trader or auctioneer, or conduct of such transient business in connection with, as a part of, or in the name of any local merchant, dealer, trader or auctioneer does not exempt any person from being considered a TRANSIENT MERCHANT.

What are examples of peddlers, solicitors and transient merchants?

- Individuals that go door-to-door to attempt to sell a product (e.g., satellite sales, construction work, etc.)
- Food truck vendors
- Temporary firework vendors

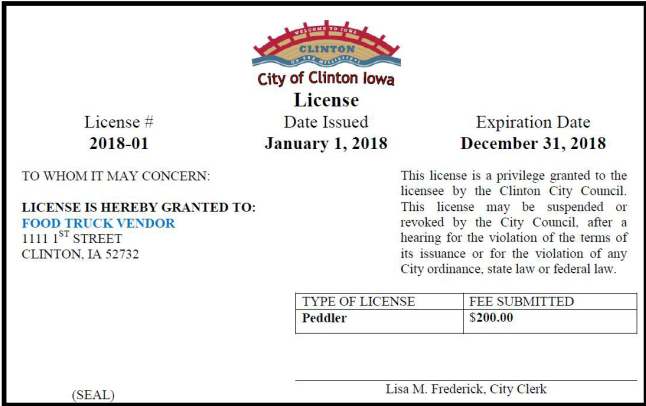
Is a City license required for peddlers, solicitors, and transient merchants?

Yes.

How can I tell if someone has a license from the City?

Licensed peddlers or solicitors that go door-to-door must wear an ID issued from the Police Department.

Vendors that operate out of a structure where customers come to them are issued a permit from the City that must be visibly displayed in the structure. Vendors that sell food are also required to have a food permit visibly displayed (issued by the Iowa Department of Inspection and Appeals).



Are there only certain times of day that someone can engaging in peddling or soliciting?

Yes. Peddling and soliciting can only occur between the hours of 8:00 A.M. and 7:00 P.M.

What is involved in the City licensing process for peddlers, solicitors and transient merchants?

City Code Chapter 112 exists to protect residents of the City against fraud, unfair competition and intrusion into the privacy of their homes. Besides gathering information about the applicant and the applicant's business, City licensing for peddlers, solicitors and transient merchants includes the completion of a background check (including sex offender registry check) and inspections (as required – e.g., food trucks).

Are there any exceptions to licensing for peddlers, solicitors, and transient merchants?

Yes, City Code Chapter 112 excludes the following from City licensing requirements: newspapers, club members (e.g., Boy/Girl Scouts, Knights of Columbus, etc.), farmers (e.g., farmers market), students (representing the School District or engaging in projects sponsored by recognized school organizations), route sales, resale or institutional use, yard sales, and emergency response sites.

How can I apply for a license or check if someone is licensed?

## Separate Sewers – A Better Way Of Life

occurred in the project area. To drain surface runoff, the City of Clinton constructed a separate storm sewer form the giant storm station along the levee up to North 3rd Street, with several additional laterals up to the Main Avenue area.

Since it was necessary to dig in a large diameter storm sewer and sanitary sewers, standard street rehabilitation did not make sense, we needed to go with a full reconstruction. In order to provide additional storage and treatment of storm water, we chose a full width permeable pavement cross section along 25th Avenue North. The design consisted of hand placed precast concrete brick pavers, laid from curb to curb. These pavers are laid atop a 2-3 foot deep rock chamber which serves to control the peak quantity and improve quality of storm effluent into the Mississippi River. This also allowed us to use a smaller storm sewer pipe, as the road base serves as an underground detention pond.

Construction of the 25th Avenue North begun last year, and despite a late start to the 2017, the contractor finished the year with a significant amount of the work done. The contractor has installed nearly two miles of new storm and sanitary pipe, replacing the singular combined sewer pipe with a new storm sewer reaching 48” in diameter and sanitary sewers reaching 24” in diameter. These changes will not only separate the storm runoff from the sanitary sewers but has dramatically increased the capacity of the overall sewer system. The sewers weren’t the only item to be checked off the list this past year.

Last year saw the completion of four of the six blocks of the new permeable pavement. For the coming year there are still two blocks of new concrete roadway to construct, between Cleveland Street and North 2nd Street. In an instance of full reconstruction with contractors already mobilized to the site, we

the city took the initiative to reconstruct pedestrian pathways throughout the project area. There are three full blocks of new sidewalk that will be installed and five blocks of recreation trail connecting to the Mississippi River Trail. As a part of the sidewalk work upon completion of the project there will be 41 new pedestrian ramps to make all sidewalks along this corridor accessible to everybody.

During the brief windows of decent weather, the contractor has been able to finish all underground and paving preparation work. Now that spring is here to stay, the plan is to finish all flatwork before summer. The construction crew is poised to take advantage of warm temperatures and soon you will see flurry of activity and concrete trucks around the site. Upon the completion of the concrete & asphalt paving, permeable brick roads, trails and sidewalks all that will remain is to clean up the site, place some fresh top soil and begin seeding all disturbed areas.

The spring schedule planned for work to be wrapped up near the end of May. While it’s possible for this to still happen, it will require warm weather to arrive tomorrow and stay indefinitely and given the spring we have had there is little confidence in counting on that. Even with the inconvenient spring construction, crews should have everything finished up around the start of June with perhaps some minor touches to be finalized after that. By the time the summer heat is upon us, the crews will be long gone to another project around town.

The next project is just a hop to the other side of Turtle Creek, and is the last project necessary to complete the north Clinton sewer separation. This project, which is scheduled to break ground next month, will involve replacement of all sanitary sewers with the Turtle Creek Basin between North 3rd Street & Pershing Blvd from 26th Ave N to 29th Avenue North. The existing sanitary sewers, which are buried under the creek, are

nearing a century old and in need of replacement. The new sewers will be constructed along street right of ways, some of which will be up to 25’ deep. This will allow abandonment of all existing clay sewers under the creek. All new storm sewer intakes will be installed within the basin, with the effluent pipes draining to the creek instead of into the sanitary sewers.

The Turtle Creek sewer separation and rehab project involves much more than just sewer separation. Contractors will also be replacing the failing bridges at 28th Avenue North & 29th Avenue North with reinforced concrete box culverts, as well as abandoning the bridge at Cleveland Street once and for all. Finally, all roads in the area will be reconstructed with full depth concrete. We chose concrete for this project as opposed to permeable pavement due to the hilly terrain. We will be scheduling a public meeting to meet with all the residents of the area and any other interested parties to discuss the project schedule and inconveniences to the neighbors. Due to the tight working conditions, this project will occupy most of the available right of way during construction.

When it’s all said and done, at long last, the City of Clinton will have separated roughly 100 acres of combined sewer, constructed two pumping stations, and reconstructed nearly 3 miles of roadway in the north end of Clinton for a total price tag of \$17 million. We not only fulfilled some necessary regulatory requirements, but also hopefully drastically reduced the amount of basement sewage backups that had been historically prevalent in this area of town. Most importantly, this region of Clinton has received the attention it has deserved but never received. Though these types of projects are frustrating for all to endure, we hope to improve the quality of life in Clinton with every project we undertake. The transformation of the entire right of way is never easy, but in this case we hope it is worth the inconvenience.

## Bicycles – Making A Comeback

On March 29th the City hosted an Open House to collect opinions and information regarding the trail network throughout Clinton. This event featured three interactive stations focused on recreation trails where individuals were able to look at maps, read about potential trail locations, cast their votes with stickers and discuss potential trails through town. The engineering department wanted to seek out the advice of those who not only use our existing trails on a regular basis but learn why some choose not to and how the trails can be reimaged to suit all users.

**STATION #1:** Each participant was given five stickers and we requested you place them on locations you already walk/run/bike or hike to or locations where you would like to be able to walk/run/bike or hike to. It is important that our trails be constructed to connect with important locations in town. Doing so will drastically increase the accessibility to our trails. At this station, we received 125 responses. Of these responses, 100 were placed on locations that had multiple responses - this accounted for 80% of the total responses to this station. That 80% comprised of 23 different locations around town. The remaining 25 votes were solitary votes scattered around town.

The 23 locations receiving multiple votes, 8 locations received 5 or more votes each. These eight locations alone commanded almost 50% of the entire vote’s that were cast at this station. They can be seen to the left highlighted in Green. You will notice that some of these locations already have access to recreation trails while some completely lack sidewalks. Having Riverview Drive show up so

high on this list reinforces the importance and the desirability of constructing recreation trails in close proximity to important locations and connecting them to other keys areas. 19th Ave North is another location that has seen an increase of users because of its newly constructed recreation trail. The locations on this list that do not have easy rec trail access would signify locations that absolutely need to be addressed in the approach of the Transportation Master Plan. Past plans have highlighted cycling and modes of alternative transportation, by knowing locations that people are either already going, or would like to attend, will aid us in deciding where future trails should be installed.

**STATION #2:** Offered participants a list of 18 potential trails and they were asked to pick their top 3 choice. This list was generated from the Engineering Department through existing documents and discussions amongst city staff personnel. In total, there were 18 potential trail and bike facility projects. These projects are scattered around town - spanning many purposes and a variety of different project scopes. The scope for some of the projects would require years or planning and a significant amount of investment while others could be achieved relatively easily and at a low cost. Participants were given a list of the 18 different projects as well as a brief description of each project. The description was meant to present a brief scope to the project to show the impact and planning necessary to achieve each project. The goal was to clearly show that while one trail may be more desirable, it does come at a greater cost.

That said of the 57 responses, there were 5 trails that received in excess of 4 votes each - they are highlighted in the table to the left. These five potential trails received 68% of all responses. When these results are compared with

the station one, the results show there is a clear overlap. The top vote getter in this station would address both the Ericksen Center and 13th Ave North - which received the 1st and 3rd highest amount of votes respectively, in station one. Second was 19th Ave North at the bridge and this reflects another top result from station one, as does the third - Mill Creek. Tied for fourth, was the North Mill Creek Extension and a trail that would run along 14th Street from Lincoln Way to Mill Creek. This option would run adjacent to locations that received 34 votes in Station 2 (Mill Creek-10, Middle School-3, 13th Ave North-7, Ericksen Center-12, Arboretum-2) not to mention additional destinations like: Whittier, Bluff, George Morris Park and the New Clinton Athletic Complex.

**STATION #3:** The final trails and biking station was an investigation into how to prioritize such a diverse list of potential projects. How to address big projects, small projects, expensive and more economical projects. Of the 25 participants attending the meeting, we received 108 votes across eleven ideals regarding recreational trails. There were six responses that received more than 10 votes each. The top three options received 48 of a possible 108 votes, or 44% of all total votes. A complete list of ideals and the number of votes can be seen to the right.

The top three options were Connections, Safety and Publicity & Awareness. Connections receiving a larger percentage of vote mimics the findings of the Parks and Rec Master plan that called for more connections between existing parks and trails. Some of the top results of Station 2 also reflect the importance of connectedness. Both the 13th Ave North and 14th Street trails were primarily suggested because of their ability to connect important parts of town and destinations and the completion of the Mill Creek paths would connect an entire loop around town. Safety is also evident in the top choices from Station 2. Thirteenth Ave N is a heavily trafficked roadway and is not ideal for cyclists or pedestrians - however, this doesn’t stop people from using it. Similarly, the connection to the north bridge has safety concerns as does riding along 19th Ave North. A path along Mill Creek presents a unique opportunity not only to complete a loop, or connect north to south, but also would offer a long, uninterrupted stretch of trail that would be unlike any other path in town. But because of the size of the road, lack of shoulders and speed of traffic, it is not suited for riding in in its current configuration.

The Discovery Trail is the most popular trail in town and is used by many people - however, not everybody is aware that it runs continuously from Eagle Point to Camanche. nor are they aware that we have other options in Clinton. Connecting our trails and parks is a great starting point to create publicity and awareness. The installation of maps at trail heads and making accessibility to visitors easier could make a big impact. As a result of this open house, the City Council has agreed to the formation of a new Trails Advisor Committee that will assist the city on a number of trail related issues. This committee will help to define the trails master plan and its necessary documents, assisting with sidewalk infill, prioritizing locations and advise the council and staff on matters concerning recreation trails, bike lanes and their maintenance.

We were pleased with the participants who took the time to stop by and share their thoughts, opinions and ideas. Collecting public opinion on these plans will be extremely useful data as we progress and begin to develop our planning documents. Many ideas can be thrown around within the department but hearing your thoughts and opinions of the people who use these facilities allows the best ideas to rise to the top. However, this is just the beginning. Over the entire timeframe needed to fully complete the Transportation Master Plan we will continue to seek out the community’s thoughts on a variety of topics. The thoughts and ideas we receive will play a huge role in the policies and projects that this Master Plan will outline. Please continue to attend future public meetings and continue to help us through the process. If you have thoughts or questions before, between or after meetings, don’t hesitate to reach out to the Engineering department. It is the City’s hope that this document will play a major role for the years to come, setting goals and guiding us along the way.

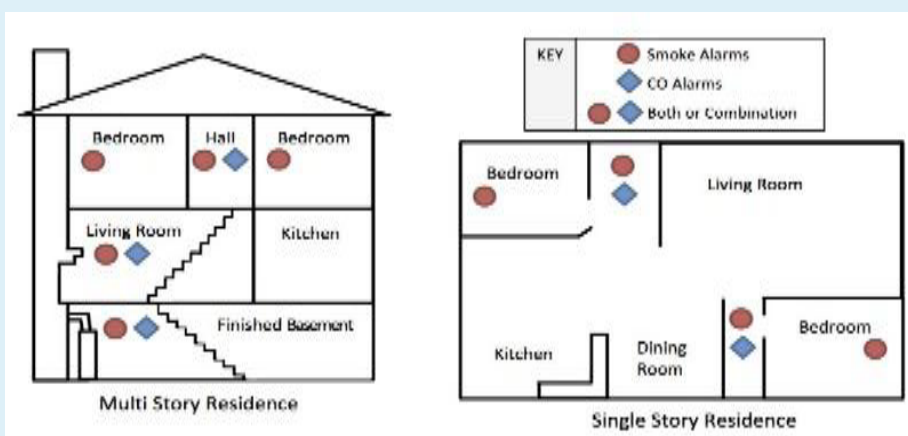
Buying a House on Contract

When buying a house, it is common to purchase a house on contract if you are concerned that a typical bank loan may not be the best possible means of buying your home. Building & Neighborhood Services would suggest that if you are buying a house on contract, that you have an attorney read the contract. Unfortunately, there are some companies out there that are less than honorable when making a deal for a contract purchase. These companies have made life difficult for some people through higher than normal down-payments; one and

done clauses which state that if you miss a payment, you are in breach of contract and the contract holder takes the house back without proper legal procedures, and; higher than normal closing costs.

These are just a few of the abnormal things that can cause you to pay more money that you ought to pay when purchasing a home. Again, always have an attorney look over your contract. The money you pay an attorney to protect you will pay off in the long run.

New Legislation for Carbon Monoxide Alarms

*The State Fire Marshal's Office is advising property owners that a new rule may require the installation of carbon monoxide alarms in their buildings. In 2016, the Iowa Legislature enacted Senate File 2219, which involves the implementation of these devices in certain single-family and residential buildings. The legislation becomes effective on July 1, 2018 and calls for structures with a fuel-fired heater or appliance, a fireplace or an attached garage be fitted with a carbon monoxide alarm. This includes existing single-family dwellings and single/multiple unit residential buildings. Under the new law, it is also mandatory for new rental units constructed after July 1 to have such a device installed. The State Fire Marshal is authorized to enforce penalties for structures that are not in compliance and allows for the creation of an inspection program. According to the Centers for Disease Control and Prevention (CDC), more than 4,000 Americans are hospitalized every year due to carbon monoxide poisoning.*

*\*\*\* As of July 1, 2018 the City of Clinton, in conjunction with the Iowa State Fire Marshal's Office, will require all structures with a fuel-fired heater or appliance, a fireplace or an attached garage be fitted with a carbon monoxide alarm. This includes existing single-family dwellings and single/multiple unit residential buildings. It is our recommendation that the above Key be used for overage. Please contact Building and Neighborhood Services at 242-2144 ext. 3 for questions in regards to this change.*

In 2016, during their regular session, the Iowa General Assembly enacted Senate File 2219. Senate file 2219 requires the installation of carbon monoxide alarms in certain single-family dwellings and single and multiple-unit residential buildings. This legislation requires the State Fire Marshal to follow and enforce the guidelines and require the installation of carbon monoxide alarms in the following structures that have a fuel-fired heater or appliance, a fireplace, or an attached garage:

Existing single-family dwellings, existing single-family rental units, and multiple-unit residential buildings.

Single-family dwellings and single-family rental units and multiple-unit residential buildings (for which construction is authorized (or is started) on or after July 1, 2018.

The legislation also requires the State Fire Marshal to enforce penalties for structures that are not in compliance. It authorizes the State Fire Marshal to implement a program of inspections; limited to the placement, repair, and operability of carbon monoxide alarms. It requires the State Fire Marshal to monitor compliance and provide notification to the owner or manager of any noncompliance issues. Building & Neighborhood Services in partnership with the State Fire Marshal's office will be responsible for the enforcement of this code.

Code states carbon monoxide alarms must be installed in the following locations:

- a. In the immediate vicinity of every room used for sleeping purposes in each dwelling unit.
- b. In each bedroom where a fuel-burning heater or furnace, fuel-burning appliance, or fireplace is located within the bedroom or its attached bathroom.
- c. In each sleeping unit, if the sleeping unit or its attached bathroom contains a fuel-burning appliance, fuel-burning heater or furnace, or fireplace.
- d. In the immediate vicinity of each sleeping unit where the sleeping unit or

its attached bathroom does not contain a fuel-burning appliance, fuel-burning heater, or fireplace and is not served by a forced-air furnace.

Code does provide some locations exceptions:

- a. There are no communicating openings between the fuel-burning heater or furnace, fuel-burning appliance, fireplace, or attached garage and a dwelling unit or sleeping unit.
- b. There are no communicating openings between the fuel-burning heater or furnace, fuel-burning appliance or fireplace and a dwelling unit or sleeping unit and when a dwelling unit or sleeping unit is located more than one story above or below an attached garage.
- c. There are no communicating openings between the fuel-burning heater or furnace, fuel-burning appliance, or fireplace and a sleeping unit or dwelling unit and the attached garage connects to the building through an open-ended corridor.
- d. A carbon monoxide alarm is located on the ceiling of the room containing the fuel-burning heater, fuel-burning appliance or fireplace, or in the first room or area between the fuel-burning heater, fuel-burning appliance or fireplace and the dwelling unit or sleeping unit.

Forced-air furnace—exception. A carbon monoxide alarm shall not be required in a dwelling unit or sleeping unit which is served by a fuel-burning forced-air furnace when a carbon monoxide alarm is located on the ceiling of the room containing the forced-air furnace or in the first room or area served by each main duct leaving the forced-air furnace and the carbon monoxide alarm signals are automatically transmitted to the occupants of each dwelling unit or sleeping unit served by the forced-air furnace.

This legislation will become effective July 1, 2018. Please contact your local building or fire department with any questions.

Building Permits

As spring is slowly but surely getting here, and the weather is eventually going to be getting nicer, building or remodeling projects are starting to bloom. Be sure to come to City Hall – Building and Neighborhood Services, to get your building permit before any work begins. Roofs, fences, decks, pools, sheds/accessory structures, AND URBAN CHICKENS, all need building permits. If you are unsure if you need a building permit, call. Most home owners can do the work themselves, but permits and inspection are typically required. Working without

a permit can get costly, as fees double and you could be subject to civil citations. Getting a permit is a simple process, only takes minutes, and we would be glad to assist you. There are miles and miles of city streets and neighborhoods that we try to keep clear and flowing. Simply by helping pick up litter or debris from the tops of these catch basins can make all the difference. We are always available to clear these, if you report them to us, as it is our "job" but if we all take pride in

our City and neighborhoods, we can all lend a helping hand -especially this time of year.

Our Maintenance crew is very busy also with pumping stations and preventative maintenance all over the City - as well as here at the plant. In the event of a flood, they play a very important part in securing the City. Everything just seems to get more hectic this time of year for them, also.

In our lab our technicians continue do all the testing needed and requested by all entities. i.e.; DNR reports and the EPA to assure our wastewater meets regulating requirements.

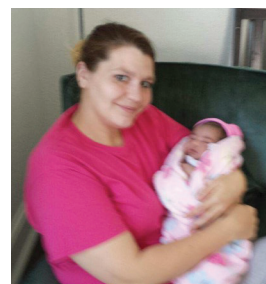
## Hailey & Robert's Story
